THE CHIEF IS PROPOSING A 2023 FORD F-150, VIN #1FTEW1EPOPKE37611. THE TOTAL COST OF THE VEHICLE INCLUDING TAXES AND FEES AND REGISTRATION IS \$52,469.76.

Chief Delfs explained that one of the command vehicles was involved in an accident in the ST 191 area. The accident report did cite the other driver. Our insurance will reimburse \$25,782 towards the purchase of a new vehicle. The information and price quoted is for a white Ford F-150 which will be used by the Fire Chief. His current red Ford F-250 will be passed on to the Battalion Chief. The new vehicle will still need lights, decals, and radio equipment.

Clerk Bren motioned to approve the purchase of a 2023 Ford F-150 with VIN #1FTEW1EPOPKE37611 at a total cost of \$52,469.76 including the taxes, fees and registration. Director Goss seconded. *Motion carried unanimously, 4:0.*
