THE PROMOTIONS WOULD BE MADE UPON THE COMPLETION OF A COMPETITIVE TESTING PROCESS TO BE CONDUCTED DURING THE THIRD AND FOURTH QUARTERS OF FISCAL YEAR 2023. THE NUMBER OF BATTALION/DEPUTY CHIEF POSITIONS CREATED WOULD BE DEPENDENT UPON THE SUSTAINABILITY OF THE DISTRICT'S FIVE-YEAR BUDGET PROJECTIONS AT THE END OF THE THIRD QUARTER OF FISCAL YEAR 2023 (MARCH 31).
