9. <u>REVIEW, DISCUSSION AND POSSIBLE ACTION</u> TO APPROVE THE AUGUST 2023 FINANCIAL REPORTS AND AUTHORIZE THE CHAIRMAN AND CLERK TO SIGN THE CERTIFICATE OF REVIEW.

We are only two months through the new fiscal year (17%). We have received 7% of the anticipated revenue and expended 15% of the budget. Director Goss motioned to approve the August 2023 financial reports and authorize the Chairman and Clerk to sign the *Certificate of Review*. Director Neilson seconded. *Motion carried unanimously*, *4:0*.

10. <u>REVIEW, DISCUSSION AND POSSIBLE ACTION</u> TO ADOPT THE RESOLUTION 2023-02 REGARDING GASB 87 PERTAINING TO LEASES

In response to the implementation of GASB87 pertaining to leases, the auditor suggested establishing a threshold for capitalization of lease agreements. The District would like to implement an accounting policy regarding GASB87 to include a threshold for inclusion under the lease standards of GASB 87 will be for leases in excess of \$10,000. Director Goss moved to adopt Resolution 2023-02 regarding GASB87 pertaining to leases. Director Neilson seconded. *Motion carried unanimously, 4:0.*

11. <u>REVIEW, DISCUSSION AND POSSIBLE ACTION</u> TO APPROVE THE REVISED AVRA VALLEY FIRE DISTRICT FINANCIAL POLICIES MANUAL REFLECTING AN UPDATED CAPITALIZATION THRESHOLD AND A SECTION ON LEASE ACCOUNTING

The *Financial Policies Manual* has been revised to reflect a \$5000 threshold for capitalization of an expense, as well as to include a policy regarding the lease threshold of \$10,000 and proper accounting treatment of a lease. Director Goss moved to adopt the revised *Financial Policies Manual*. Director Neilson seconded. *Motion carried unanimously, 4:0*.
