Ms. Palmquist addressed the Board to summarize District assessed value information. The highest Net Assessed Value (NAV) for the District in recent years was in FY11. Over the next ten years, the District lost 11.50% of the assessed value, with the most significant impact occurring in FY17. The assessed values reported currently show a 9% rebound. It has taken 13 years for the District to come back up to the assessed values of FY11. Clerk Bren motioned to approve the January 2023 financial reports and authorize the chairman and Clerk to sign the *Certificate of Review*. Vice-Chairman Armendarez seconded. *Motion carried unanimously*, 5:0.
