An employee on light duty works a 40-hour week rather than a regular shift schedule.

Chief Klein explained that authorizing this Resolution will allow the District to increase the billable rates for Fire Recovery incidents. Incidents covered under the fire Recovery agreement are non-District resident motor vehicle accidents, car fires and house fires. We have not increased the mitigation rates since 2010. Vice-Chairman Bauer motioned to approve Resolution 2022-03 authorizing the implementation of current allowable mitigation rates for Fire Recovery. Director Armendarez seconded. Motion carried unanimously, 3:0.
