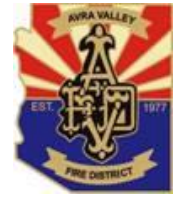

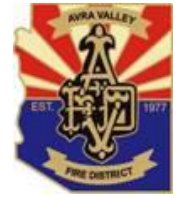
#### **5. CALL TO THE PUBLIC**

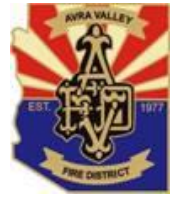
