4) **Public Hearing on Proposed Budget FY2020**

Pursuant to A.R.S. 48-805 and 48-807, The Avra Valley Fire District through its Board of Directors, has prepared an annual budget that contains detailed estimated expenditures for the fiscal year and clearly shows salaries payable to employees of the District, including the Fire Chief. In accordance with State statute, the *FY20 Proposed Budget* was posted in four public places and on the District's website for twenty days prior to holding this Public Hearing for the purpose of adopting said budget. Copies of the budget have also been made available to members of the public upon written request to the District. Following this second Public Hearing, the District Board may adopt the budget, whereafter a complete copy of the *FY20 Adopted Budget* shall be posted in a prominent location on the District's official website within seven business days and shall be retained on the website for at least sixty months.

Because no members of the public were present, Chairman Castaneda motioned to open and close the public hearing. Clerk Neilson seconded. *Motioned carried unanimously, 4:0.* The public hearing was adjourned into regular session at 6:06 PM.
